TERMS AND CONDITIONS OF DEPUTATION OF THE POST OF DEPUTY CHIEF ACCOUNTS OFFICER (CL-I) IN ACCOUNTS DEPARTMENT VISAKHAPATNAM PORT TRUST.

1. PERIOD OF DEPUTATION

The period of deputation will be of 3 (three) years from the date of taking overcharge of the post subject to curtailment / extension.

Age limit for deputationist is not prescribed, but maximum age limit for an appointment made on deputation does not exceed 56 years on the closing date of application and the crucial date for determine the eligibility criteria is also on the closing date of application.

2. PAY & Allowances

During the period of deputation Shri/Smt ______ will have the option either to get his/her pay fixed in the scale of Rs.24900-50500 attached to the post of Deputy Chief Accounts Officer (CL-I) in Visakhapatnam Port Trust under the normal rules or the pay attached to the post held by him in his/her parent department viz., _____ plus Deputation (duty) Allowance in accordance with and subject to the conditions as modified from time to time and such general or special orders issued by the Ministry of Shipping in this regard.
