1.	No. of Posts	Medical Officers : 06 (Six) (Unreserved -5, OBC-1)
2.	Upper Age Limit	40 years as on 01-06-2019 Age is relaxed by 3 years for OBC-NCL candidates
3.	Minimum Qualification & Experience	Degree in Medicine i.e. MBBS recognized by either State Medical Council or MCI. Two year Post qualification experience as on 01-06-2019 is desirable.
4.	Duration of Engagement	Engagement will be on Contractual basis for ONE Year from the date of joining. The same is extendable on yearly basis at the discretion of the Management. Each term will be a fresh contract and at the end of each yearly term, contract will be deemed to have been expired. In case of extension, the extended term shall be treated as fresh contract of service and not as continuity.
5.	Working Hours	The Medical officers may have to work in Split Duty Timings i.e. 8:00 AM to 12.30PM and 3.30PM to 7.00PM (or) Shift duties in A, B, C shifts on working days.
6.	Leaves	10 days paid leaves shall be allowed during the period of one year tenure.
7.	Remuneration /Honorarium	A consolidated pay of Rs.75,000/- (Rupees Seventy Five Thousand only per month.
8.	Accommodation	Accommodation will be provided at Company's township as per the rates applicable to regular employees of RINL, in executive cadre. Electricity and water charges on actual consumptions will be payable by the Medical Officers as per the rates applicable to regular executives of RINL.
9.	Medical Facility	Free Medical facility to self, spouse and dependent children will be provided to the extent available at VSGH
10.	Termination of Contract	The contract will stand terminated at completion of the prescribed tenure. The contract may also be terminated during the tenure with two month's notice in writing by either side.

11. Selection Process:

The Mode of Selection is through Shortlisting of eligible applications. Depending on the number of eligible applications received the selection process shall vary i.e., through Online test and Personal Interview followed by Medical Examination (or) Personal Interview followed by Medical Examination.
