The applicants who are presently working in judiciary as District Judges or Tribunals equivalent shall submit their applications through proper channel.

Term of Office:

Every President of the District Commission shall hold office for a term of **four years or up to the age of sixty five years**, whichever is earlier and shall be eligible for reappointment for another term of four years subject to the age limit of sixty five years, and such reappointment is made on the basis of the recommendation of the Selection Committee.

Pay & Allowances: (C.P (Salary, allowances..) Model Rules, 2020:

The President shall be entitled to the salary and allowances as are admissible to a District Judge in the super time scale of pay. The pay of a person appointed as President, who is in receipt of any pension, shall be reduced by the gross amount of pension drawn by him. There shall be an annual upward revision of the pay of the President at the rate of 3%. Every District Commission President shall be entitled to House Rent Allowance, Transport Allowance, Leave, Leave Travel Concession, Medical Treatment and Hospital facilities as per the provisions applicable to Group 'A' Government Servants in the State Government.

The applicant for the above posts are requested to submit the applications in duplicate in prescribed Format only along with the copies of all testimonials attested by a Gazetted Officer and send them to the Ex-Officio Secretary to Government, Consumer Affairs, Food and Civil Supplies Department, A.P Secretariat, Velagapudi, Amaravati. The applications should reach this Department on or before O6-O4-2021 by 5.00 P.M. Incomplete or defective applications not accompanied with attested copies of all testimonials and the applications received after the due date will not be considered on any ground, including postal delay.

Procedure for selection of applicants to the post of Presidents:

After scrutiny of the applications received, short listed applicants will be called for **interview**. No Travelling Allowance or any other expenses will be paid to the applicants.

Call letters will be sent to the short listed applicants for the interview and venue in advance at the appropriate time. The Government reserves the right either to postpone or cancel this notification at any point of time without assigning any reason.

The Selection Committee shall, on the basis of the assessment made by it in the interview and after satisfying the eligibility criteria and after taking into account the suitability, record of past performance, integrity and adjudicatory experience, will recommend a panel of names of applicants for appointment as Presidents from amongst the applicants in the order of merit for approval to the State Government and for issuance of appointment orders to the selected applicants.
