# 2. Applications received after the due date and incomplete applications or applications not submitted in the prescribed format will not be considered.

3. Number of vacancies may vary.

4. These positions will be filled purely for temporary extramural project for appointment purely on temporary CONTRACT basis and co-terminus with the project.

5. The advertised post are tentative without commitment for its filling. Recruitment will depend upon requirement of the Institute and approval of the competent authority.

6. Emoluments: The rates of emoluments/stipend shown in this advertisement are as per the funding agency guidelines NCDC and may vary according to the sanction from the same.

7. Age Concession: Age relaxation is admissible in respect of SC/ST/OBC, Physically Handicapped candidates in accordance with the instructions issued by funding agency from time to time.

8. Cut-off date for age limit will be the date of notification.

9. Separate application should be submitted for each post.

10. Qualification & experience should be in relevant discipline/field and from an Institution of repute. Experience should have been gained after acquiring the minimum essential qualification.

11. Mere fulfilling the essential/educational qualification does not guarantee the selection.
