Sub: Filling up of the vacancy of Dy. Chief Engineer (Dy. HoD) on scale of pay of Rs.80000-220000 under composite method of Recruitment in Civil Engineering Department, Visakhapatnam Port Trust – Reg.

It is proposed to fill up (01) one vacant post of Dy. Chief Engineer (Dy. HoD) on scale of pay of Rs.80000-220000 in Engineering Department of Visakhapatnam Port Trust which fell vacant w.e.f.01.12.2021, by absorption through composite method, from the eligible officers of Major Ports, who possess the prescribed qualifications, experience and other conditions as mentioned in the Recruitment Rules appended.

Names of suitable and willing officers, who satisfy the provisions in the approved Recruitment Rule for the above post may be furnished together with their applications as per the proforma enclosed along with the following documents to the undersigned on or before <u>21.01.2022</u>. The crucial date for determining the eligibility of the applicants is 01.12.2021.

- Copies of ACRs of the applicant for the last five years (up to March, 2021) (duly attested by an Officer not below the rank of Dy. HoD on each page). Non-availability certificate is necessary in case of non-availability of ACR to that particular year.
- 2) Attested photocopies of all certificates.
- 3) No Objection Certificate of respective Port.
- 4) Vigilance/Administrative clearance of the concerned Port/organization in the revised proforma prescribed by the Ministry vide letter No.I-26/18/201-PE-I dt.17.08.2010.
- 5) An Undertaking of the applicant not to withdraw, if selected.
- 6) The details of the applicant may clearly be mentioned along with length of service in the feeder grade posts and details of pay scales.
- 7) It may clearly be mentioned whether the candidate has experience in the feeder grade posts in regular or Adhoc or deputation basis.
- 8) The applications of non-eligible candidates (i.e. who are not in the feeder grade posts) may not be sent
- 9) Three copies of recent pass port size photographs.

Instructions of the candidates:

Interested eligible candidates are requested to apply online against this circular on the "Online Application Portal (OAP)" of the Ministry of Ports, Shipping and Waterways website <a href="http://onlinevacancy.shipmin.nic.in">http://onlinevacancy.shipmin.nic.in</a>. The link will be open from <a href="http://onlinevacancy.shipmin.nic.in">23.12-2021</a> to <a href="http://onlinevacancy.shipmin.nic.in">21.01.2022</a>. The candidates at first has to register themselves in the OAP. After applying through online, the candidate has to take printout of the online application and submit the same along with the self-attested photocopies of supporting documents and 2 recent passport size photographs to concerned port. Incomplete applications or applications received late may not be considered.

In terms of Ministry's letter dated 09.07.2020, the Appointing Authority as well as Disciplinary Authority for all Dy. HoD level posts will be the Central Government i.e. Secretary (MoPSW). In this connection, all Major Ports are directed to carry out amendments in their Service Regulations viz. Recruitment Rules (RRs), Seniority and Promotion (RS&P), Classification, Control and Appeal and other relevant Regulations (wherever required) as per the laid down procedure.

Subsequently, the Ministry, vide letter dated 29.12.2020 has conveyed that "till amendments in the service Regulations viz. Recruitment Rules (RRs), Seniority and Promotion (RS&P), Classification, Control and Appeal and other relevant Regulations are notified, Dy. HoD level posts in Major Port Trusts may be filled up only by absorption through composite method at Port level. Advertisement for filling up of the posts, DPC etc, may be held at Port level. However, recommendations of DPCs may be covered by Major Port Trusts to this Ministry and obtain approval of the Ministry before issuing appointment orders."

It is informed that, if he/she selected to the post of Dy. Chief Engineer (Dy. HoD) on scale of pay of Rs.80000-220000 of Civil Engineering Department in Visakhapatnam Port Trust, under composite method will be governed by the Service Rules and Regulations in force as amended from time to time.

Applications received through proper channel within the due date will only be considered. Applications received after the last date or without the ACR's or otherwise found incomplete will not be considered. However, in terms of Ministry instructions dt.11.08.2021, in case of receipt of advance copy of application, the candidature shall be considered only if the application through proper channel is received within **15** days from the last date of receipt of application mentioned in para 2 above.
